MCS offers a full time, optional five day Junior Kindergarten and a full time, five day Senior Kindergarten program and classes for students in Grade 1-8.

TUITION POLICY

MCS is operated by MCEA as an independent, not-for-profit, Christian elementary school. As such, we do not receive any funding from governments or other organizations or institutions.

In order to operate our school, including the support of facility rental, payroll and other costs, we are wholly reliant on tuitions to operate the school on a day to day basis. The timely payment of all tuitions is essential to our providing the services of the school.

2012-2013 Tuition Rates

The school offers several options for tuition payment:

Registration Fee – A registration fee of \$500 is due on the March 1st prior to the school year. The registration fee is credited against the last payment due in the relevant school year. (see chart below)

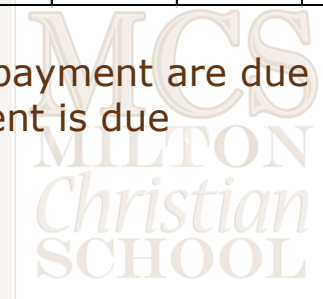
Monthly – Payment is made on the 1st of the month prior to the school month. Post dated cheques for the entire school year are due on the date of the first payment (see chart below)

Semi-annual – Annual tuition assessment is payable in 2 payments with a post dated cheque for the second payment due on the date of the first payment (see chart below)

2012-2013 Tuition Rates

Tuition not paid by the due date is considered in arrears.

When arrears reach 7 days from the due date a notice is sent to the family requiring immediate payment. If arrears exceed 30 days or there are more than 2 incidents of arrears (for any length of time) in a school year the school reserves right to rescind enrollment of the family's student(s).

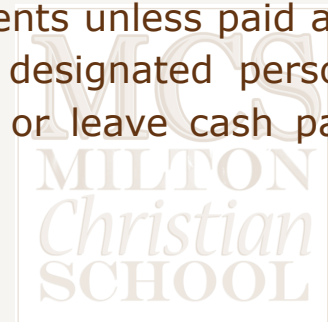
It shall be the responsibility of the tuition payers to inform the Principal that they will be unable to meet the required tuition by the deadline.

Upon registration, tuition paying parents/assignees are legally bound to make the respective tuition payments. Tuition paying parents/assignees have entered into a legal contract with the Milton Christian Education Association whereby, MCS agrees to provide certain services, and the parents/assignees agree to pay a certain fee for those services.

If parents/or assignees decide to withdraw students from MCS, a 30-day notice period is required. Following the 30 day notice, all other tuition previously submitted will be returned/reimbursed. A \$200 enrolment cancellation fee will also be applied to any student withdrawing early from MCS.

Cheques returned to the school for non sufficient funds (NSF) put the family in an arrears situation. An NSF charge of \$35.00 is charged to the family.

The school is not responsible for cash payments unless paid and receipted at prescribed times and to the designated person. Please do not send cash through the mail or leave cash payments un-receipted and unattended.
